
We are in compliance with the requirements set by the REACH-Regulation (EC) No 1907/2006 and are closely following any modification of the REACH-Regulation as well as of the candidate list. We shall inform you in the framework of our business relations about the changes to our products resulting from REACH and agree on suitable measures on a case-by-case basis.

With regard to article 33 of the REACH-Regulation, we would like to communicate the following information: An information, on whether the recently added substances of the current candidate list in our articles or their packagings in a concentration above 0.1 mass-% cannot yet be given, because firstly information of our suppliers must become available.

According to the published substances of very high concern (SVHC) on the previous candidate list and to the new REACH article definition as ruled out by the ECJ sentence issued on September 10, 2015, we inform you about the SVHC that have been reported to us by article suppliers in our upstream supply chain.

The SVHC listed in the table as attached on page 2 of this statement are contained in a concentration above 0.1% (w/w) in articles that are supplied to Unify whereas such articles are used by Unify to manufacture/assemble the finished Unify products.
